Auditor Recommendations and Conclusion

Overall Impression

After conducting a comprehensive desk audit, an onsite audit was conducted at Slieve Elva. The onsite audit encompassed interviews, observations at the business site, as well as interviews with a supplier to the business and a local network in which the business actively participates. This multi-faceted approach allowed for a thorough assessment and provided an exceptionally positive impression of Slieve Elva's exceptional commitment to sustainability.

During the onsite interviews and spots checks, the statements made online and/or verbally were confirmed. Indeed, additional information was provided to support how ingrained sustainability is within the business. It was apparent that Slieve Elva, is a business deeply committed to sustainability, and has implemented various initiatives to promote environmental responsibility. They utilise brewery grain for bread production and repurpose apple cores. Furthermore, the installation of solar panels, bio-gas facilities, an ozone generator on the washing machine and an organic pond, exemplify their dedication to sustainable practices. They actively support other members of the Burren Ecotourism Network and have received visits from educational institutions. They also promote local guides and tours and collect guests from public transport and promoting e-bikes.

As part of their commitment to sustainability, Slieve Elva actively engage with the Burren Ecotourism Network, local suppliers e.g., he Burren Smokehouse and have participated in various training courses and funding applications through the Burren Bio Trust. These efforts align with the geopark label, focusing on preserving local heritage and wildlife. They have also engaged in the HospitableMe program with the aim of providing an inclusive, respectful welcome to all customers and guests, no matter their identity.

During the meetings with the Burren Ecotourism Network and the Burren Smokehouse, Slieve Elva's sustainability was portrayed in a very positive light. The Burren Ecotourism Network went so far as to state that Slieve Elva showcased themselves as a shining light in the industry. They have demonstrated their commitment to sustainable practices by adopting the Code of Practice passionately, actively participating in various initiatives, supporting spring cleans, and even involving the Scouts in these efforts. They consistently volunteer, serving as a positive example to other volunteers. They share their experiences with others, allowing small businesses to see what can be achieved through local support in terms of sustainability and environmental practices. To which end, Kris from Slieve Elva now mentor's other businesses in the Burren Ecotourism network on sustainable practices.

As outlined above their sustainability commitment extends beyond their own business, and this was recognised when they won an award for their exceptional achievements in 2022 Geopark Code of Practice awards.

Additional Remarks

To maximize their impact, Slieve Elva should maintain a comprehensive record of all visits from educational institutions, organisations, and businesses on site. This record, organised on a spreadsheet, would effectively document their engagements, and provide a valuable resource for showcasing their sustainable practices to inspire others.

In addition, instead of solely seeking students/interns to assist with the day-to-day operations of their B&B, Slieve Elva should offer students the opportunity to actively participate in the biodiversity work being conducted on their premises. By involving students/interns in these on-site initiatives, Slieve Elva can provide them with valuable hands-on experience and contribute to their understanding and appreciation of environmental conservation.
